TEMPORARY CONSTRUCTION EASEMENT NORTH OF FAIRGROVE ROAD WEST OF WESTERVILLE ROAD COLUMBUS, OHIO

Thence along said easterly line and said westerly line with the arc of a curve to the left having a radius of 3,092.36 feet, a central angle of 2°08'25", an arc length of 115.52 feet, the chord of which bears North 49°38'11" East, a chord distance of 115.51 to a point;

Thence South 87°57'58"East, through said 58.466 acre tract, a distance of 94.85 feet to a point in the easterly line of said 58.466 acre tract and the westerly line of that 7.610 acre tract as described in a deed to Columbus and Southern Electric Company, of record in Deed Volume 1695, Page 439;

Thence along said easterly and westerly lines with the arc of a non-tangent curve to the right having a radius of 3,158.36 feet, a central angle of 02°02'12", an arc length of 112.27 feet, the chord of which bears South 48°20'09" West, a chord distance of 112.27 feet to a point;

Thence North 89°11'36"West, through said 58.466 acre tract, a distance of 104.65 feet to a point in the westerly line of said tract and the easterly line of said Lot 312;

Thence along said easterly and westerly lines with the arc of a non-tangent curve to the left having a radius of 3,092.36 feet, a central angle of 00°08'12", an arc length of 7.37 feet, the chord of which bears North 50°46'30" East, a chord distance of 7.37 feet to the place of beginning and containing a total of 0.178 acre of land, excepting therefrom the above described permanent easement area of 0.065 acre, leaving a net acreage of 0.113 acre of land.

Bearings herein were established with GPS observations of Ohio Cors Stations and is based NAD 83 (2011 adjustment) Ohio State Plane Coordinate System, South Zone.
