While his experience is diverse enough, there is no information about his progression, his specific involvement with security related professions and absolutely nothing about the employees.

### 2. Does the bidder have experience that includes other governmental agencies (10 Points)

Comments: Of the six references he offers, he lists the Columbus Metropolitan Library, which may be the closest entity to this type of application, however, there is no indication of how long, whether or not it is still current and/or what else they are involved with. It would appear that his current clients are primarily offices/warehouses after hours or in a limited role (15,000 + hours annually doesn't seem like much for 19 employees).

Comments: The references for the bidder indicate a strong influence with governmental agencies, such as: Corp of Engineers in Michigan, Federal Aviation Administration in Illinois, National Archives & Records Administration in MD, Department of Veterans Affairs in MI and Environmental Protection Agency in NC. All of this correlates with the bid specifications as written, however, the lack of a local bidder brings up many potential drawbacks.
