Situated in the State of Ohio, County of Franklin, City of Columbus, part of Quarter Township 3, Township 1, Range 16, United States Military Lands and being part of a 4.997 acre tract of land in the name of Abdulaziz Abdiraghe, Mohamed Elmi, Abdirahman Adan, and Abdirisaq Yusuf, as described in IN. 202106220108795, all records are on file in the Franklin County Recorder's Office, and being a tract of land lying on the left side of the centerline of Right of Way of State Route 16 (East Broad Street) hereafter referred to as S.R. 16, as shown on the FRA-16-7.79 plans made by the Ohio Department of Transportation, and is more particularly described as follows:

Beginning for Reference at a concrete monument found in the southerly Right of Way line of said S.R. 16 (East Broad Street), being 33.00 feet right of centerline Station 205+00.00 as delineated in the FRA-16-7.79 centerline plat as recorded in Plat Book 29, Page 4;

Thence North 08°08'48" West, perpendicular to and leaving said southerly Right of Way line a distance of 33.00 feet to a point in said centerline, being centerline Station 205+00.00;

Thence North 81°51'12" East, with said FRA-16-7.79 centerline, a distance of 349.32 feet to the southwesterly corner of a 1.242 acre tract of land in the name of Lifetime Investments, Inc., an Ohio corporation, f/k/a Leslie Development Company, Inc. as described in IN. 201512020169272, at centerline Station 208+49.32;

Thence North 03°41'05" East, with the westerly line of said 1.242 acre tract, a distance of 107.28 feet to the northwesterly corner of said 1.242 acre tract, the southeasterly corner of a 1.400 acre tract of land in the name of Indus Broad Street Hotel, LLC, an Ohio Limited Liability Company

as described in IN. 201909200123231, in the northerly Right of Way line of said S.R. 16 (East Broad Street) being 105.00 feet left of centerline Station 208+71.32;

Thence North $81^{\circ}51'12''$ East, with said Right of Way line, a distance of 244.96 feet to a point at the southeasterly corner of a 5.000 acre tract of land in the name of SH 724 LLC, a Delaware limited liability company as described in IN. 200812220182539, being 105.00 feet left of centerline Station 211+16.28, referenced by a $5/8''$ iron pin with a cap stamped "The Kleingers Group" found bearing South $17^{\circ}47'49''$ West a distance of 0.44 feet and being 104.60 feet left of centerline Station 211+16.09, and the **True Place of Beginning** for the tract of land herein being described;

Thence North $03^{\circ}40'15''$ East, with the easterly line of said 5.000 acre tract, a distance of 5.11 feet to an iron pipe set 110.00 feet left of centerline Station 211+17.33;

Thence North $81^{\circ}51'12''$ East, through said 4.997 acre tract, a distance of 71.64 feet to an iron pipe set in the westerly line of a 0.701 acre tract of land in the name of WH Capital, L.L.C., a Georgia limited liability company as described in IN. 200205080116345, being 110.00 feet left of centerline Station 211+88.97;

Thence with said westerly line, a curve to the left having a radius of 20.00 feet, an arc length of 14.45 feet, a central angle of $41^{\circ}24'35''$, a chord bearing of South $77^{\circ}26'31''$ East and a chord distance of 14.14 feet to a point in said northerly Right of Way line and the northerly line of said 1.242 acre tract, being 105.00 feet left of centerline Station 212+02.22, referenced by a $5/8''$ iron pin with a cap stamped "Kleingers & Assoc" found bearing South $18^{\circ}58'52''$ East a distance of 0.45 feet and being 104.59 feet left of centerline Station 212+02.03;

Thence South $81^{\circ}51'12''$ West, with said Right of Way line and said northerly line, a distance of 85.92 feet to the **True Place of Beginning**.

The above described area contains 0.009 acres, more or less, of which the present road occupies 0.000 acres, more or less, which is part of Franklin County Auditor's Permanent Parcel number 520-295661-00.

Iron pins set are $13/16''$ inside diameter iron pipe, 30" long with a yellow cap stamped "OHM".

Bearings for this description are based on Ohio State Plane Coordinates, South Zone, NAD 83 (2007) Datum as established utilizing a GPS survey performed in November 2017, holding North $82^{\circ}20'12''$ East for the centerline of East Broad Street (State Route 16).
