AMENDMENT 3

This **Amendment 3** to agreement DCY-G-2627-0482 (“the “Amendment”) is between the State of Ohio, Department of Children and Youth (“DCY”) and Columbus Public Health (the “Grantee”). This Amendment changes the terms of Agreement DCY-G-2627-0482 (the “Agreement”).

WHEREAS, the Ohio Department of Health (“ODH”) and Grantee entered into the Agreement on October 1, 2023;

WHEREAS, ODH assigned the Agreement to DCY on July 1, 2024 and DCY and Grantee amended the Agreement on November 7, 2024 (“Amendment 1”), and on September 24, 2025 (“Amendment 2”); and

WHEREAS, DCY and Grantee determined that an amendment is necessary to address certain revisions to the Agreement.

NOW, THEREFORE, the Agreement is amended as follows:

1. The parties agree to extend the Agreement term for an additional six-month period, with a new Agreement end date of June 30, 2026.
2. The total Grant amount is increased by One Hundred Seventy-Nine Seven Hundred Seventy-Five Dollars (\$179,775.00).
3. Any and all budgets previously attached to or incorporated into this Agreement are hereby deleted in their entirety and replaced with Exhibit 1 – Budget SFY26 Amend. 3.xlsx, attached hereto.

This Amendment shall become effective as of the date of DCY’s signature and shall remain in full force and effect for the term of the Agreement. Except as modified by this Amendment, all other terms, conditions and pricing of the Agreement shall remain the same and in full force and effect.
