- 5. A description of work performed to date as part of the contract and a full description of work to be performed during any future phasing of the contract.**

This is a contract for HVAC & Air Purification Maintenance Services for the Department of Public Utilities facilities at Southerly Water Reclamation Plant, Jackson Pike Water Reclamation Plant, Compost Facility and Division of Power substations and buildings. Other Department facilities may be added in the future. The work to be performed under this contract will be mainly HVAC & Air Purification units and their associated equipment and systems that require inspection, sampling, testing, troubleshooting, balancing, media replacement, maintenance, and repair or replacement of failed components. The work may also include updating of software for the various HVAC units or any HVAC associated equipment. Maintenance and repair of piping and ductwork are also considered part of the HVAC and Air Purification systems and therefore part of the required work.

The regular inspection and maintenance of the HVAC and Air Purification Equipment results in the expected and planned life for this equipment. The HVAC and Air Purification equipment provides proper environmental requirements to areas housing sensitive electronics and electrical equipment which monitors, operates and controls many plant processes and equipment. Without the proper environmental requirements, corrosive conditions could cause the failure of these components. Removal and replacement of the failed equipment, both HVAC, electronic and electrical components, would be a major impact to the budget. No community outreach or environmental factors are considered for this project.

This is the third renewal.

Renewal #1 – \$455,000.00 = \$425,000.00 – DOSD and \$30,000.00 - DOP (PO413547)

Renewal #2 – \$475,000.00 = \$475,000.00 – DOSD (PO466076)

Renewal #3 – \$448,700.00 = \$438,700.00 – DOSD and \$10,000.00 - DOP (PENDING)

Renewal #4 – \$410,000.00 = \$400,000.00 – DOSD and \$10,000.00 - DOP (FUTURE)

The contract will continue to provide HVAC & Air Purification Maintenance Services for various Department of Public Utilities Facilities. This contract renewal will also provide necessary carbon media replacement for select air purification units.

Anticipated renewal. The original contract allows for four (4) extension periods on a year to year basis. This renewal is to provide the funding necessary for the payment of services to be provided through October 2026.

11. An explanation of why the work to be performed as part of the contract modification cannot be bid out. (Indicating the work to be a logical extension of the contract is not sufficient explanation.)

The same exact service is required as originally bid. No lower pricing/more attractive terms and conditions are anticipated at this time.

This contract will be funded incrementally with renewals on approximately an annual basis. Four contract renewals are anticipated at this time for DOSD and DOP Facilities. If other DPU Facilities are added, if unforeseen issues or difficulties are encountered that would require additional funding, a modification would be requested. The expected cost for this project is as follows:

Original Contract - \$447,628.00 = \$417,628.00 (DOSD) (PO355671) and \$30,000.00 (DOP) (PO355671)

Renewal #1 - \$455,000.00 = \$425,000.00 (DOSD) and \$30,000.00 (DOP) (PO413547)

Renewal #2 - \$475,000.00 = \$475,000.00 (DOSD) (PO466076)

Renewal #3 - \$448,700.00 = \$438,700.00 (DOSD) and \$10,000.00 (DOP) (PENDING)

Renewal #4 - \$410,000.00 = \$400,000.00 (DOSD) and \$10,000.00 (DOP) (FUTURE)

Total Estimated Cost - \$2,236,328.00
