Furnishing all materials, equipment, and labor necessary to retrofit light fixtures, remove existing light fixtures and replace with new energy efficient light fixtures at the Dublin Road Water Plant, the Parsons Avenue Water Plant, and the 910 Dublin Road Public Utilities Complex, in alignment with the Mayor's Green Initiative. The intent of this project is to qualify for the Efficiency Smart rebate program.

6. **A narrative timeline for the contract including a beginning date, beginning and ending dates for known phases of the contract and a projected ending date.**

Work for this project shall be completed within 120 calendar days of the Notice to Proceed.

7. **A narrative discussing the economic impact or economic advantages of the project; community outreach or input in the development of the project; and any environmental factors or advantages of the project.**

This project will provide for the upgrades to existing lighting system and installation of energy efficient lighting system at the Dublin Road Water Plant, the Parsons Avenue Water Plant, and the Utilities Complex. The project will replace T12 lamps with more efficient T8 lamps and replace high pressure sodium lamps with LED lamps for an approximate 30% reduction in energy consumption. The work on this project was coordinated with EnergySmart to qualify for the Efficiency Smart rebate program.
