

PARCEL 38-T
DESCRIPTION OF 0.0141 ACRES

Situated in the State of Ohio, County of Franklin, City of Columbus, and being in Section 14, Township 2, Range 16, United States Military Lands, being part of Lot 221 of West Albany Section 2 A Subdivision Of Reserve A And Reserve B Thereof, as dedicated in Plat Book 94, Page 44, as conveyed to Christian T. Lizotte and Lauren N. Smith, as recorded in Instrument No. 201601210007595, all being of record in the Recorder's Office, Franklin County, Ohio.

Being a parcel of land lying on the left side of the centerline of Harlem Road, and being more particularly described as follows:

BEGINNING for reference at existing monument FCGS 5574 at the centerline intersection of Central College Road and Harlem Road South, also said centerline of Central College Road being on the southerly line of Section 7 and the northerly line of Section 14, and also being the northeasterly corner of a 1.617 acre tract as conveyed to the City of Columbus as recorded in Official Record Volume 22969 Page A01;

Thence along the easterly line of said 1.617 acre tract, and the centerline of Harlem Road, **South 05 degrees 44 minutes 20 seconds East, 156.82 feet** to a point, being 0.00 feet right of Harlem Road centerline station 28+56.11, referencing existing monument FCGS 5575 at **South 05 degrees 44 minutes 20 seconds East, 2277.75 feet**;

Thence leaving said centerline and across said 1.617 acre tract, **South 84 degrees 15 minutes 40 seconds West, 30.00 feet** to an iron pin found, being 30.00 feet left of Harlem Road centerline station 28+56.11, being located on the westerly line of said 1.617 acre tract and Harlem Road, also being the northeast corner of said Lot 221 and the southeast corner of Lot 220 of said West Albany Section 2 A Subdivision, as conveyed to David B. Salazar and Jeanna M. Wolford, as recorded in Instrument No. 201406110072357, said iron pin also being the **TRUE POINT OF BEGINNING** for the parcel herein described;

Thence along the westerly line of said 1.617 acre tract and Harlem Road and the easterly line of said Lot 221 **South 05 degrees 44 minutes 20 seconds East, 123.21 feet** to an iron pin found, being 30.00 feet left of Harlem Road centerline station 27+32.90, being the southeast corner of said Lot 221 and the northeast corner of Lot 222 of said West Albany Section 2 A Subdivision, as conveyed to Roger E. Doles Jr. and Carol A. Doles, as recorded in Instrument No. 201709150129575;

Thence across said Lot 221 **North 10 degrees 36 minutes 13 seconds West, 117.92 feet** to a point, being 40.00 feet left of Harlem Road centerline station 28+50.40, being on the northerly line of said Lot 221 and the southerly line of said Lot 220;

Thence along the southerly line of said Lot 220 and the northerly line of said Lot 221, **North 54 degrees 31 minutes 31 seconds East, 11.52 feet** to an iron pin found, being 30.00 feet left of Harlem Road centerline station 28+56.11, said iron pin being the **TRUE POINT OF BEGINNING**, containing 0.0141 acres, more or less.

Subject however to all legal easements, restrictions and rights of way of record and of records in the respective utility offices.

The above described area contains a total of 0.0141 acres within Franklin County Auditor's Parcel Number 010-252990-00, which includes 0.000 acres in the present road occupied.

Iron pins set are 5/8" rebar, 30" in length with a yellow plastic cap with "EP FERRIS SURVEYOR 8230" inscribed on top.

The preceding description is based on the Ohio State Plane Coordinate System, South Zone, NAD83 (2012A). Said bearings originated from a field traverse which was referenced to said coordinate system by GPS observations and observations of selected stations in the Ohio Department of Transportation Virtual Reference Station network. The portion of the centerline of right of way of Central College Road, from the intersection with Harlem Road bearing easterly 1648.10 feet and having a bearing of South 86 degrees 10 minutes 10 seconds East, is designated the "basis of bearing" for this description.
