## **DESCRIPTION OF 0.008 ACRES**

## Temporary Easement The Board of Trustees of Columbus Metropolitan Library 4093 Cleveland Ave

Situated in the State of Ohio, County of Franklin, City of Columbus, being located in Quarter Township 1, Township 1 North, Range 18 West, United States Military Lands and being inclusive of Lot 1 thru Lot 5 and described as a 1.265 acres tract of land and also Lot 6 with a vacated alley (vacated by resolution number 633-90) described as a 1.082 acres tract of land as the same is numbered and delineated upon the recorded plat Keffler-Lehner Highlands in Plat Book 15, Page 35 and described in multiple deeds to The Board of Trustees of Columbus Metropolitan Library by deeds of reference in Official Record Book 16177G04 and Official Record Book 16177G06 respectively. All references to records herein are those located in the Recorder's Office of Franklin County, Ohio and being more particularly described as follows:

Commencing at the intersection of the north line of the grantor's tract with the westerly right of way for Cleveland Avenue (80' width) this location, said intersection also being the northeast corner of the grantor's tract;

Thence S 03 degrees 43 minutes 55 seconds W a distance 150.48 feet with the westerly right of way line of Cleveland Avenue and the east line of the grantor's to a point, said point being the TRUE POINT OF BEGINNING;

Thence continue **S 03 degrees 43 minutes 55 seconds W** a distance **5.00 feet** with the westerly right of way line of Cleveland Avenue and the east line of the grantor's tract to a point;

Thence N 86 degrees 16 minutes 05 seconds W a distance 4.00 feet across the grantor's tract to a point, said point being 4.00 feet west of the westerly right of way line for Cleveland Avenue as measured by right angles;

Thence S 03 degrees 43 minutes 55 seconds W a distance 49.00 feet across the grantor's tract with a line being 4.00 feet west of and parallel with the westerly right of way line for Cleveland Avenue as measured by right angles to a point;

Thence S 86 degrees 16 minutes 05 seconds E a distance 4.00 feet across the grantor's tract to the westerly right of way line for Cleveland Avenue, same being the grantor's east line;

Thence S 03 degrees 43 minutes 55 seconds W a distance 5.50 feet with the westerly right of way line of Cleveland Avenue and the east line of the grantor's tract to a point;

Thence N 86 degrees 16 minutes 05 seconds W a distance 9.00 feet across the grantor's tract to a point, said point being 9.00 feet west of the westerly right of way line for Cleveland Avenue as

measured by right angles;

Thence N 03 degrees 43 minutes 55 seconds E a distance 59.50 feet across the grantor's tract with a line being 9.00 feet west of and parallel with the westerly right of way line for Cleveland

Avenue as measured by right angles to a point;

Thence S 86 degrees 16 minutes 05 seconds E a distance 9.00 feet across the grantor's tract to the westerly right of way line for Cleveland Avenue, same being the grantor's east line and the

TRUE POINT OF BEGINNING, containing 0.008 acre of land more or less.

The above described area contains a total of 0.008 acres within Franklin County Auditor's

Parcel Number 010-218850-00, which includes 0.000 acres in the present road occupied.
