# **Estimate Total Cost of Streetscape Project**: \$368,240.00

## Estimate Total Cost of Adjacent Private Development Project: \$59,000,000.00

### Streetscape Description

The streetscape at 300 E. Town Street and on Sixth Street, Town Street, State Street and Grant Avenue will be as shown on the submitted plan:

- New street trees to be added adjacent to the new surgery center at the northeast corner of Sixth Street and Town Street.
- Concrete sidewalks to be installed adjacent to the new surgery center at the northeast corner of Sixth Street and Town Street.
- Granite curbing to installed adjacent to the new surgery center at the northeast corner of Sixth Street and Town Street.
- 11 street lights of decorative design required by the Downtown Streetscape Plan to be installed on Town Street, State Street and Grant Avenue.

#### Adjacent Property Description

The Grant Surgery Center under construction at the northeast corner of Sixth Street and Town Street is a five-story, 175,000 square foot surgery pavilion and heart hospital with multiple connections to the existing Grant Medical Center. Baldwin Tower was imploded on this property to make room for this project. The exterior façade of the surgery center is a combination of brick, metal panels and glass.

The facility will include 18 operating room, a heart hospital, pre and post-operation areas to support the surgery and heart hospital functions. The facility will also contain a new food court area for the entire Grant Medical Center campus. The food court will have both indoor seating as well as an outdoor covered patio eating area at the corner of Sixth and Town Streets. The completed building will serve as the new primary entrance for the Grant Medical Center campus with the provision of a multi-story vehicular drop-off area near the corner of Sixth and Town Streets that will be accessible from Sixth Street.
