Obarski, Trustee of Timothy P. Obarski Trust Dated October 22, 2003 in Instrument 200505040084481 in the Franklin County Recorder's Office. The below described parcel laying on the right side of Courtney Place, and being more particularly described as follows:

COMMENCING at an 5/8 inch iron pin found at the grantor's northeast corner being the northeast corner of said Lot 6, and being on the west existing Right of Way line of Courtney Place (35' R/W) and the southeast corner of lot 5 being conveyed to Valerie K. Piccininni as recorded in Instrument 201304090057933, and being the **TRUE POINT OF BEGINNING** for the parcel herein described:

- 1) **Thence**, along said west existing Right of Way line, **South 02 degrees 29 minutes 03 seconds West, 10.00 feet** to a 8 inch mag nail set;
- 2) **Thence**, across the grantor's tract, **North 87 degrees 30 minutes 57 seconds West, 2.82 feet** to an iron pin set;
- 3) **Thence**, across the grantor's tract, **North 01 degrees 07 minutes 38 seconds East, 10.00 feet** to an iron pin set on the common line between lots 5 and 6;
