The original contract provided for engineering design for the work and the original authorizing legislation (#0474-2005) indicated "The expenditure for construction administration services will be authorized by a future modification when the scope of services can be better defined." The only work for which a modification was not anticipated at the time of executing the original contract are listed in the attached document "Modification 11 06". These design changes were implemented after the Value Engineering process and after discussions with plant staff. The total cost of these proposed changes are \$296,627 of the total requested modification cost of \$4,318,963. All other costs included in this modification request were previously anticipated.

As indicated in the original contract and legislation, a modification was always planned. During the preparation of the original engineering scope development it was decided that it was not possible to accurately project anticipated costs for construction administration and construction inspection until the design had been substantially completed.
