Situated in the State of Ohio, City of Columbus, Franklin County, Quarter Township No. 3, Township 1, Range 17, U.S. Military Lands and being part of Lots 534 and 535 in the C.E. Morris Trustee, ETAL., East Columbus Addition recorded in Plat Book 5, page 364-366 and conveyed to Seneca Properties, LLC., in Instrument 201511240165886 in the Franklin County Recorder's Office. The below described parcel laying on the right side of the proposed centerline of right of way for Cassady Avenue in project FRA-C.R. 96-1.71. (Cassady Ave.) as platted by 2LMN, Inc. and recorded in Instrument 202109170166308, being Plat Book 131, Page 66, and being more particularly described as follows:

COMMENCING at an iron pin set at the northwest corner of Lot 537 in said C.E. Morris Trustee, ETAL., East Columbus Addition, being on the southerly existing right of way for E. 7th Ave. (50' R/W) and the easterly existing right of way for Cassady Ave., said point being 30.05 feet right of the proposed right of way and construction for Cassady Avenue at station 27+93.63. Thence, along the west line of Lots 534 through 537 and the easterly existing right of way for Cassady Ave., South 09 degrees 35 minutes 04 seconds West, 139.48 feet at the southwest corner of said Lot 534 and the northwest corner of Lot 533 conveyed to the City of Columbus, Ohio, in Deed Book 1249, Page 506, being the grantor's southwest corner and being on the easterly existing right of way for Cassady Avenue, said point being 19.70 feet right of the centerline of proposed right of way and construction for Cassady Avenue at station 26+53.18 and being the **TRUE POINT OF BEGINNING** for the parcel herein described:

- 1) **Thence**, along the west line of said Lots 534, 535 and the easterly existing right of way for Cassady Avenue, **North 09 degrees 35 minutes 04 seconds East, 70.00 feet** to a point at the northwest corner of said Lot 535 and the southwest corner of Lot 536 conveyed to Aburaida Properties, LLC., an Ohio Limited Liability Company in Instrument 201911060147889, said

point being 25.62 feet right of the centerline of proposed right of way and construction for Cassady Avenue at station 27+22.93;

- 2) **Thence**, along the north line of said Lot 535 and the south line of said Lot 536, **South 80 degrees 08 minutes 28 seconds East, 9.44 feet** to an iron pin set, said pin being 35.00 feet right of the centerline of proposed right of way and construction for Cassady Avenue at station 27+22.09;
- 3) **Thence**, across said Lot 535 and 534, **South 04 degrees 44 minutes 16 seconds West, 70.30 feet** to an iron pin set on the south line of said Lot 534 and the north line said Lot 533, said pin being 35.00 feet right of the proposed centerline of Cassady Avenue at station 26+51.79;
- 4) **Thence**, along the south line said Lot 534 and the north line of said Lot 533, **North 80 degrees 04 minutes 48 seconds West, 15.38 feet** to the **TRUE POINT OF BEGINNING**, containing 0.020 acres.

The parcel of land described contains, 0.020 acres, more or less of which 0.011 acres in Franklin County Auditor's Parcel Number 010-073857-00, and 0.009 acres in Franklin County Auditor's Parcel Number 010-072995-00 including the present road occupies 0.000 acres, more or less.

All irons pins set are 5/8 inch x 30 inch rebar with a 1 inch plastic cap stamped "2LMN, Inc".

The bearings shown hereon are based on the centerline of Cassady Avenue from Margaret Street to East 7th Avenue as being North 09 degrees 35 minutes 04 seconds East, from an adjusted field survey using GPS methods from the nearby City of Columbus monument (COC32-82), nearby United States Geological Survey monument (802.52USGS), and Continually Operating Reference Station (CORS) COLB, based on the Ohio State Plane Coordinate System, South Zone, and North American Datum 1983 (NSRS 2007) scaled to ground by 1.000042617 about the projection origin (0,0).
