The project consist of installing 78 Decorative street light poles and LED luminaires, removing HPS luminaires and upgrading to a 3-wire underground conduit system. The project encompasses the North Linden area of Cleveland Avenue, between Weber Rd and Dunedin Rd (Planning Area No. 40).
