3. A description of work performed to date as part of the contract and a full description of work to be performed during any future phasing of the contract.

The work includes furnishing professional services for Construction Administration Services during 2008-2010 on projects for the Division of Power and Water (DOPW) and the Division of Sewerage and Drainage (DOSD). The work includes full time or part time construction administration services including resident project inspection for the specific project identified. In general the Consultant will respond to contractor's requests for information, respond to inquiries regarding the interpretation of the contract documents, review contractors claims for additional services and costs, review quality or materials/equipment substitutions and provide recommendations to the City, coordinate project submittals, schedule and chair progress meetings, and other services as directed by the City.

The work for Modification number 1 involved the replacement and or rehabilitation of sanitary and combined sewer infrastructure. The project involved in this specific modification was the Beulah Road Trunk Sewer Rehabilitation (Glen Echo Restoration).

The work for Modification number 2 under this contract includes furnishing professional services for Construction Administration and Construction Inspection Services during 2008-2010 on projects for the Division of Sewerage and Drainage (DOSD) and Storm Water. This

project typically involves the replacement and or rehabilitation of sanitary and combined sewer infrastructure. The projects involved in this specific modification are two sanitary projects: (1) General Construction Contract and (2) 2009 Annual Lining Contract; and one stormwater project: Floodwall Concrete Repair.

The work for Modification number 3 under this contract includes additional inspection services for CIP650676 Stanton Area Sewer Improvements for an extended construction phase.

The original contract was for a duration of three years beginning in 2008 and ending in 2010. The duration for the two sanitary projects: (1) General Construction Contract and (2) 2009 Annual Lining Contract; and one stormwater project: Floodwall Concrete Repair.

The original project duration for CIP650676 was 365 days and it was estimated that the project would not require full-time inspection for the entire period. There were 1264 hours allotted for the Resident Project Representative in the original cost summary. After reviewing the effort required to date, it is believed that the original estimate was correct assuming the project had been completed by the contract completion date. The estimate would also have been sufficient if Reynolds and their subcontractors had worked concurrently, but due to cold weather, the manhole rehab was delayed until spring and the construction completion date was extended from May 1st to June 30th.

The modification request is for an additional 300 hours for the RPR. This is the equivalent of 7.5 weeks of inspection assuming 40hr/week. Even with the modification, the total CA/CI cost will be below 10 percent of the construction cost.

The original contract selected three firms to provide construction administration services for projects in 2008, 2009, and 2010.
