Thence across the said church tract with a curve to the left having a radius of 293.00 feet, a delta angle of 15°45'45", and a chord that bears N 80°23'33" W a chord distance of 80.35 feet to a point;

Thence across the said church tract, N 87°00'22" W a distance of 433.17 feet to a point;

Thence across the said church tract, S 4°13'06" W a distance of 197.05 feet to a point;


Thence across the said church tract, S 54°12'31" W a distance of 38.62 feet to the northerly line of the said subdivision;
