



Taxes, Permits and Fees:	U.S. Customs Duty is included however no allowances are made for local, state, or Federal taxes, permits, and fees.










Comments: Pricing is valid only for the calendar year in this offer letter. Engine lubricating oil is changed subject to Jenbacher scheduled intervals. Oil samples are required per Jenbacher scheduled intervals, no less than monthly. Oil analysis may advise increased frequency of oil change subject to fuel gas quality, wear elements, or coolant contamination. Increased demand for lube oil will result in additional charges as required.

Any proposed lube oil and filter changes are included only during scheduled maintenance intervals. Routine oil level inspections and additional of make-up oil are performed by Owner personnel unless we provide operating services. Additional oil and filter changes required beyond scheduled maintenance intervals, for any reason, will be additional charges as required.
