Fortuity co-locates non-profit agencies that provide employees with an ecosystem of support. These agencies include Columbus Works, Mount Carmel Health Systems, Columbus Early Learning Centers and Grace Blossoms Counseling.

Katie began working in Franklinton in 2014 developing the business plan for Fortuity and fundraising for its launch. She and her co-founder Fred Brothers have personally guaranteed the financing and job commitments for this project, making a significant commitment to the community.
