The following information has been provided concerning the City of Columbus' 2014 – 2015 annual objection to the renewal of liquor permits. After reviewing the State of Ohio, Franklin County, and City of Columbus' records regarding the above listed liquor permit establishment, the following information has been compiled with regard to a potential objection to the renewal of the permit issued by the State of Ohio.

The above listed liquor establishment has been issued a liquor permit from the State of Ohio, Division of Liquor Control, Permit # 2568968. The permit holder received a C1 permit, & a C2 permit. These permits grant the permit holder the privilege to sell beer and/or intoxicating liquor for off premises consumption as described by Ohio Law.

An "Inquiry of Violations" was received from the State of Ohio, Division of Liquor Control. The inquiry revealed that the permit holder has received the following administrative violations within the past 12 months

This case was heard by the Ohio Liquor Control Commission on 11/05/2014, at which time the Commission sustained the violation. The commission ordered a 5 day suspension of the permit or that the Permit Holder pay a \$500 fine. The permit Holder has until 12/17/2014 to pay the fine

Case Number: 02

09/24/2010

The Permit Holder has been charged with the violation of Sale and/or Furnishing to a person under 21 This case has been assigned case #13-11 by the Liquor Control Commission. This case was heard by the Ohio Liquor Control Commission on 1/11/2011, at which time the Commission sustained the violation. The commission ordered a 12 day suspension of the permit or that the Permit Holder pay a \$1,800 fine. The permit Holder did not paid the fine and served the suspension.

Case Number: 01

11/27/2007

The Permit Holder has been charged with the violation of Improper Conduct. This case has been assigned case #57- 09 by the Liquor Control Commission. This case was heard by the Ohio Liquor Control Commission on 5/15/2009, at which time the Commission sustained the violation. The commission ordered a 3 day suspension of the permit or that the Permit Holder pay a \$300 fine. The permit Holder paid the fine on 6/23/2009.
