Situated in the State of Ohio, County of Franklin, City of Columbus, being located in Quarter Township 3, Township 2, Range 16 of the United States Military Lands and being 0.004 acres within a 0.999 acre parcel conveyed to KEYBANK NATIONAL ASSOCIATION, a national banking association as described in Instrument Number 200311170366389 and being more particularly described as follows:

Being a parcel of land lying on the right side of the centerline of a survey made for project Hamilton Road, made by the Department of Transportation, and being located within the following described points in the boundary thereof:

Commencing for reference at Franklin County Geodetic Survey (FCGS) monument #6666 found in the centerline of Hamilton Road (120' R/W), being at Station 95+50.62 and being South 3°19'21" West a distance of 1586.64 feet, along the centerline of right-of-way of Hamilton Road, from Franklin County Geodetic Survey (FCGS) monument #8813 found;

Thence from the said FCGS #6666 and along the said centerline of right-of-way of Hamilton Road, North 3°19'21" East a distance of 76.27 feet to a point at Station 96+26.89;

Thence South 86°40'39" East a distance of 47.00 feet to an iron pin set on the existing easterly right-of-way line of Hamilton Road as created by a conveyance to the City of Columbus of record in Official Record 28614A07, being 47.00 feet right of Station 96+26.89 and being the True Point of Beginning;

Thence along the said existing easterly right-of-way line of Hamilton Road as created by a conveyance to the City of Columbus of record in Official Record 28614A07, North 3°19'21" East a distance of 14.50 feet to an iron pin set in the said easterly right-of-way line of Hamilton Road as conveyed to the City of Columbus in Official Record 28614A07 at 47.00 feet right of the centerline Station 96+41.39;

Thence along the said easterly right-of-way line of Hamilton Road and the easterly line of the said tract conveyed to the City of Columbus in Official Record 28614A07, South 86°40'39" East a distance of 13.00 feet to an iron pin set, being 60.00 feet right of centerline Station 96+41.39;

Thence across the said 0.999 acre tract, South 3°19'21" West a distance of 14.50 feet to an iron pin set in the easterly line of the said tract conveyed to the City of Columbus in Official Record 28614A07 at 60.00 feet right of centerline Station 96+26.89;

Thence along the said easterly right-of-way line of Hamilton Road and the easterly line of the said tract conveyed to the City of Columbus in Official Record 28614A07, North 86°40'39" West a distance of 13.00 feet to the True Point of Beginning, containing 0.004 acres, more or less.

The above described parcel contains 0.004 acres, more or less, including the present road occupies which is 0.000 acres, for a net take of 0.004 acres, more or less from Auditors Permanent Parcel Number 010-267636.

All iron pins set are 5/8 inch rebar (30 inches long) with a yellow plastic cap stamped "R/W Dynotec, Inc." and are to be set after construction.

Grantor claims title by Instrument Number 200311170366389, in the Franklin County Recorder's Office.

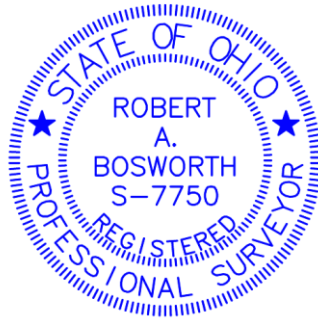
