This memorandum is a recommendation for construction contractor selection and processing the construction legislation for the Roadway Improvements – Guardrail 2012 project.

Project Scope:

The Department of Public Service is responsible for maintaining the City's roadway system in a safe manner. A guardrail and fence repair contract is needed to restore accident-damaged guardrail and fence, replace deteriorating structures and install new structures. The primary function of this contract is to repair accident-damaged guardrail and fence throughout the entire City of Columbus network.

Fiscal Impact: Source of funds is operating funds.

Contract amount: \$250,000.00

Inspection funds are not needed as inspection will be performed by Division of Planning and Operations.

Schedule: Bids were opened February 23, 2012; estimated Council date is March 26, 2012; estimated NTP date is April 18, 2012. The contract has a completion date of April 18, 2013.
