Situated in the State of Ohio, County of Franklin, Township of Blendon and the City of Columbus, being located in Quarter Township 4, Township 2, Range 17 of the United States Military Lands and being 0.149 acres within a 0.588 acre parcel conveyed to Katie R. Hixon, Trustee & Gary L. Bonecutter, Trustee, as described in Instrument Number 200110180240017, subject to a 40 foot standard highway easement designated right-of-way Parcel 50, as appropriated by the Franklin County Commissioners in Road Record 19, Page 192, and being more particularly described as follows:

Being a parcel of land lying on the left side of the centerline of a survey made for project Hamilton Road, made by the Department of Transportation, and being located within the following described points in the boundary thereof:

Commencing for reference at Franklin County Geodetic Survey (FCGS) monument #6666 found in the centerline of Hamilton Road (120' R/W), being at Station 95+50.62 and being South 3°19'21" West a distance of 1586.64 feet, along the centerline of right-of-way of Hamilton Road, from Franklin County Geodetic Survey (FCGS) monument #8813 found;

Thence from the said FCGS #6666 and along the said centerline of right-of-way of Hamilton Road, North 3°19'21" East a distance of 157.19 feet to a mag nail set at the southeast corner of the said 0.588 acre tract, the northeast corner of a tract conveyed to the City of Columbus in Official Record 24824A09, in the centerline of Hamilton Road at Station 97+07.81 and the True Point of Beginning;

Thence along the southerly property line of the said 0.588 acre tract and the northerly line of the said tract conveyed to the City of Columbus in Official Record 24824A09, North 85°46'11" West a distance of 60.01 feet to an iron pin set at the northeast property corner of the 0.666 acre tract conveyed to Barton Investment LLC in Instrument Number 201111230153383 and being 60.00 feet left of centerline Station 97+08.76;

Thence across the said 0.588 acre tract, North 3°19'21" East a distance of 108.18 feet to an iron pin set in the southerly property line of a 1.500 acre tract conveyed to Christopher M. Krisiewicz, Tr. in Instrument Number 201509110128077 and being 60.00 feet left of centerline Station 98+16.94;

Thence along the southerly property line of the 1.500 acre tract, South 85°48'39" East a distance of 60.01 feet to a mag nail set at the southeast property corner of the said 1.500 acre tract and being at centerline of Hamilton Road Station 98+16.03;

Thence along the said centerline of right-of-way of Hamilton Road, South 3°19'21" West, a distance of 108.22 feet to the True Point of Beginning, containing 0.149 acres, more or less.

The above described parcel contains 0.149 acres, more or less, including the present road occupies which is 0.099 acres, for a net take of 0.050 acres, more or less from Auditors Permanent Parcel Numbers 112-000047.

All iron pins set are 5/8 inch rebar (30 inches long) with a yellow plastic cap stamped "R/W Dynotec, Inc." and are to be set after construction.

This description is based upon a field survey performed by Dynotec, Inc. in January, 2015.

Grantor claims title by Instrument Number 200110180240017 in the Franklin County Recorder's Office.

The basis of bearings shown are based on the State Plane Coordinate System, Ohio South, as per NAD 83 (96 CORS) established by Dynotec, Inc. using GPS procedures and equipment, which sets the centerline of Hamilton Road as North 3°19'21" East.

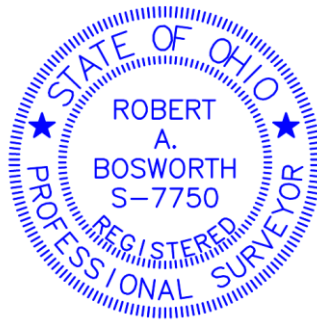
