



Statement of Hardship

The council variance request is to permit gas sales. The area is zoned for commercial development and the gas use is in association with a permitted use under the zoning. The current zoning permits C-4 uses. The sale of gas is not a C-4 use, therefore a council variance is necessary to permit that use. The granting of this variance will not impair an adequate supply of light and air to the adjacent property, unreasonably increase the congestion of Public Streets, increase the danger of fires, endanger the public safety, unreasonably diminish or impair the public health, safety, comfort, morals, or welfare of the inhabitants of the City of Columbus.




