Utility Cut & Restoration Project.

Asphalt services include the repair of existing or future streets and the items associated with utility cut repairs: excavation, driveway pavement replacement, pavement planning, crack sealing, flowable controlled density fill, brick street repair, pumping water from cuts, mill and overlaying, etc.

Concrete services include the repair of existing or future sidewalks and curbs and the items associated with utility cut repairs: remove walkways, curbs & gutters, excavation, concrete pavement, walks, curbs, gutters, topsoil furnished and replaced, seeding 7 mulching, sidewalk ramps moved & installed, etc.

An updated contract timeline to contract completion.

These are annual repairs. The current contract shall expire in Spring 2006, whereas, the Division intends to either re-bid these services, or modify these contracts through Spring 2007, and the possibility through Spring 2008.

This modification was not anticipated as we thought the original funding would carry us through the end of the contracts (Spring 2006). We underestimated the amount of funds needed for asphalt and concrete repairs, mainly because these services, along with heat welding, were in one combined contract. Since we broke out all three services into three different contracts, we really needed more funds in asphalt and concrete repairs than in heat welding.

The work should not be bid out because we are still obligated under the original contract, which will end in Spring 2006. It is not Decker Construction's fault that we under-allocated funds in the wrong contract.
