

**0.109 ACRE TEMPORARY EASEMENT
DYER-LAZAR HSTS ELIMINATION

Situated in the State of Ohio, County of Franklin, Township of Jackson, Virginia Military Survey Number 4641, being part of a 1.765 acre tract conveyed to Danniell L. McQuirt and Pamela M. McQuirt in Instrument Number 201403270037341, all records being of record in the Recorder's Office, Franklin County, Ohio, and being more particularly described as follows:

COMMENCING from FCGS 6112, being a bronze disk in PVC encased concrete monument, being at an angle point in the centerline of Dyer Road (R/W varies);

Thence along the centerline of said Dyer Road, North 80°13'35" East, 1223.20 feet to a point, being the northeasterly corner of said 1.765 acre tract and the northwesterly corner of a 0.531 acre tract conveyed to Richard L. Sarolberry and Rena L. Sarolberry in Official Record Volume 17031 Page H08;

Thence leaving said centerline, along the easterly line of said 1.765 acre tract and the westerly line of said 0.531 acre tract, South 14°33'10" East, 290.58 feet to a point, said point being the **TRUE POINT OF BEGINNING**:

Thence continuing along the easterly line of said 1.765 acre tract and the westerly line of said 0.531 acre tract, South 14°33'10" East, 9.99 feet to a point, being a southeasterly corner of said 1.765 acre tract, the southerly corner of said 0.531 acre tract, and being on the westerly line of a 2.0449 acre tract conveyed to Roger A. Hambel and Joanna L. Pugh in Instrument Number 201710030137387;

Thence along the westerly line of said 2.0449 acre tract and the easterly line of said 1.765 acre tract, South 13°45'50" West, 23.05 feet to a point;

Thence across said 1.765 acre tract, South 74°00'54" West, 158.07 feet to a point, being on the westerly line of said 1.765 acre tract and the easterly line of Lazar Road (R/W varies);

Thence along the westerly line of said 1.765 acre tract and the easterly line of said Lazar Road, North 11°59'57" East, 31.47 feet to an angle point in the easterly line of said Lazar Road and a westerly corner of said 1.765 acre tract;

Thence continuing along the easterly line of said Lazar Road and the westerly line of said 1.765 acre tract, North 20°38'19" West, 2.22 feet to a point;

Thence across said 1.765 acre tract, North 74°00'54" East, 155.17 feet to a point, said point being **POINT OF TRUE BEGINNING**, containing 0.109 acres (4,734 S.F.), more or less.

Subject however to all legal easements, restrictions and rights of way of record and of records in the respective utility offices.

Bearings referenced herein are based on a portion of the centerline of Dyer Road as being North 80°13'35" East as determined by GPS observations utilizing Ohio Department of Transportation's Virtual Reference Station, based on Ohio State Plane South Zone (NAD 83, 2011 adjustment).
