DPU will provide a list of staff with email addresses, and passwords, in Microsoft Excel or similar format, to create online training user profiles. DPU will be able to delete usernames, change passwords, run reports, and send broadcast emails.

Evaluation of current course list and status to provide to client on age of all courses for assessment as to which courses are obsolete or in need of update.
