Situated in the State of Ohio, County of Franklin, Township of Plain and the City of Columbus, being located in Quarter Township 3, Township 2, Range 16 of the United States Military Lands and being 0.169 acres within a 1.920 acre parcel conveyed to April L. Gates, as described in Official Record 17887, Page D09, subject to a 40 foot standard highway easement designated right-of-way Parcel 63, as appropriated by the Franklin County Commissioners in Road Record 19, Page 192, and being more particularly described as follows:

Being a parcel of land lying on the right side of the centerline of a survey made for project Hamilton Road, made by the Department of Transportation, and being located within the following described points in the boundary thereof:

Commencing for reference at Franklin County Geodetic Survey (FCGS) monument #6666 found in the centerline of Hamilton Road (120' R/W), being at Station 95+50.62 and being South 3°19'21" West a distance of 1586.64 feet, along the centerline of right-of-way of Hamilton Road, from Franklin County Geodetic Survey (FCGS) monument #8813 found;

Thence from the said FCGS #6666 and along the said centerline of right-of-way of Hamilton Road, North 3°19'21" East a distance of 1219.35 feet to a mag nail set at the northwest corner of a 1.956 acre parcel conveyed to Sara Z. Rastegar by Instrument Number 200410260246960 at Station 107+69.97 and the True Point of Beginning;

Thence along the said centerline of right-of-way of Hamilton Road, North 3°19'21" East, a distance of 122.47 feet to a mag nail set at the southwest corner of a tract conveyed to the City of

Columbus in Instrument Number 200408230196800, and being in the centerline of Hamilton Road at Station 108+92.44;

Thence along the southerly line of the said tract conveyed to the City of Columbus in Instrument Number 200408230196800, South 86°54'39" East a distance of 60.00 feet to an iron pin set at the southwest property corner of the 1.495 acre tract conveyed to TJB Investments LLC in Instrument Number 200409010205552 and being 60.00 feet right of centerline Station 108+92.68;

Thence across the said 1.920 acre tract, South 3°19'21" West a distance of 122.46 feet to an iron pin set in the northerly property line of the said 1.956 acre tract and being 60.00 feet right of centerline Station 107+70.22;

Thence along the northerly property line of the said 1.956 acre tract, North 86°54'39" West a distance of 60.00 feet to the True Point of Beginning, containing 0.169 acres, more or less.

The above described parcel contains 0.169 acres, more or less, including the present road occupies which is 0.112 acres, for a net take of 0.057 acres, more or less from Auditors Permanent Parcel Number 220-000869.

All iron pins set are 5/8 inch rebar (30 inches long) with a yellow plastic cap stamped "R/W Dynotec, Inc." and are to be set after construction.

This description was prepared and reviewed on April 26, 2016 by Robert A. Bosworth, Registered Surveyor #7750.

This description is based upon a field survey performed by Dynotec, Inc. in January, 2015.

Grantor claims title by Official Record 17887, Page D09, in the Franklin County Recorder's Office.

The basis of bearings shown are based on the State Plane Coordinate System, Ohio South, as per NAD 83 (96 CORS) established by Dynotec, Inc. using GPS procedures and equipment, which sets the centerline of Hamilton Road as North 3°19'21" East.

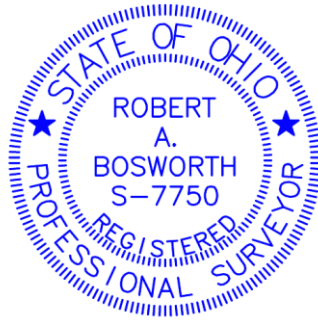
