Commencing for reference at a railroad spike set at the intersection of the existing centerline of right-of-way for Livingston Avenue and the existing north centerline of right-of-way for James Road, being the southwest corner of said ½ Section 29, said point being 34.65 feet left of James Road proposed centerline of construction station 104+07.31;

Thence North 04 degrees 27 minutes 26 seconds East, along the existing north centerline of right-of-way for James Road and along the west line of said ½ Section 29, a distance of 279.51 feet to a point, said point being 7.12 feet left of James Road proposed centerline of construction Station 106+78.04;

Thence **South 85 degrees 32 minutes 34 seconds East**, along a line perpendicular to the previous course, a distance of **39.84 feet** to a point on the existing east right-of-way line for said James Road, as established by said Schaffner's Addition, being the southwest corner of said Lot 4, and being the northwest corner of Lot 5 of said Schaffner's Addition, as said Lot is described in a deed to Eileen Y. Crenshaw, of record in Instrument Number 200010050203058, said point being 32.57 feet right of James Road proposed centerline of construction Station 106+81.30, and said point being the **TRUE POINT OF BEGINNING** for the herein described right-of-way parcel;

Thence North 04 degrees 30 minutes 02 East, along the existing east right-of-way line for said James Road and along the west line of said Lot 4, a distance of 54.18 feet to the northwest corner of said Lot 4, being the southwest corner of Lot 3 of said Schaffner's Addition, as said Lot is described in a deed to Patrice Meyers, of record in Official Record 14952, page E15, said point being 30.88 feet right of James Road proposed centerline of construction Station 107+32.90;

Thence South 85 degrees 39 minutes 58 seconds East, along the north line of said Lot 4 and along the south line of said Lot 3, a distance of 7.00 feet to an iron pin set, said iron pin set being 37.88 feet right of James Road proposed centerline of construction Station 107+32.91;

Thence South 04 degrees 30 minutes 02 seconds West, across said Lot 4, a distance of 19.12 feet to an iron pin set at a point of curvature, said iron pin set being 37.92 feet left of James Road proposed centerline of construction Station 107+14.35;

Thence along the arc of a curve to the right, continuing across said Lot 4, said curve having a radius of 396.66 feet, a central angle of 05 degrees 04 minutes 16 seconds, and an arc length of 35.11 feet to an iron pin set on the south line of said Lot 4, being the north line of said Lot 5, said iron pin set being 38.00 feet right of James Road proposed centerline of construction Station 106+81.72, said curve being subtended by a long chord having a bearing of South 07 degrees 02 minutes 10 seconds West and a length of 35.10 feet;

Thence North 85 degrees 39 minutes 58 seconds West, along the south line said Lot 4 and along the north line of said Lot 5, a distance of 5.45 feet to the TRUE POINT OF BEGINNING for the herein described right-of-way parcel.

The above described right-of-way parcel contains a total area of **0.008 acres** located within Franklin County Auditor's parcel number 010-095781.

The bearings described herein are based on Grid North (reference South 85 degrees 47 minutes 50 seconds East for Livingston Avenue east of James Road) as referenced to the Ohio State Plane Coordinate System (South Zone) and the North American Datum of 1983 (CORS '96). As established utilizing a GPS survey referencing ODOT CORS stations "COLB", "OHLI" and "OHMD".

Iron pins set are 30" by 5/8" diameter rebar with caps stamped "American Structurepoint PS 8438".
