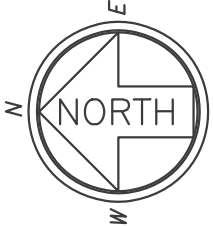

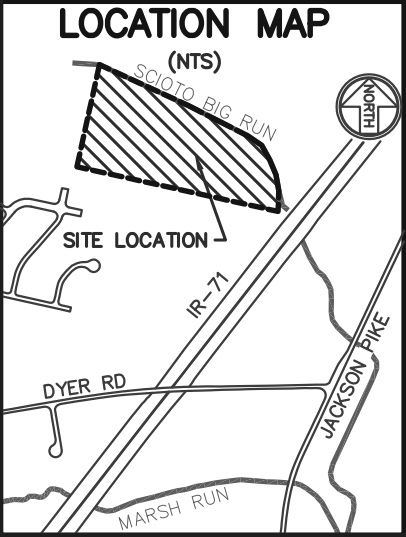
TOTAL PERIMETER OF THE ANNEXATION AREA IS
