

**Information to be included in all Legislation Modifying Contracts:**

**There is not a change in the scope of the contract. Original contract specifications allowed for three (3) renewals. This is the final renewal period. The Division of Sewerage and Drainage will formally bid the contract in mid-2006**

An explanation of why the work to be performed as part of the contract modification cannot be bid out. (Indicating the work to be a logical extension of the contract is not sufficient explanation)

**After review of the market, there is not a benefit for the Division of Sewerage and Drainage to re-bid the contract. Duke's represents the best cost at this time.**
