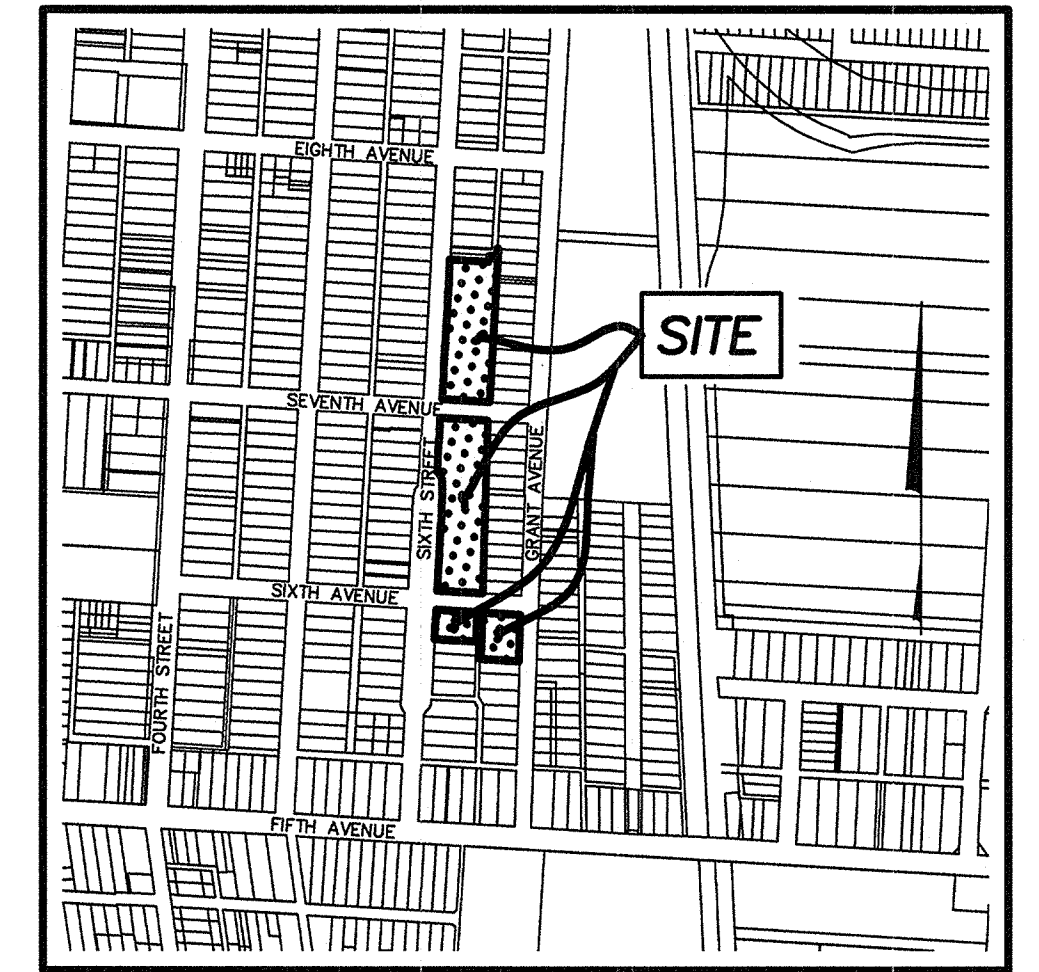


WEINLAND PARK

(A RESUBDIVISION OF ALL OF LOTS 104 TO 117, BOTH INCLUSIVE, AND PART OF LOT 103 AND PART OF LOTS 121 TO 134, BOTH INCLUSIVE, OF "FELIX A. JACOB'S SUBDIVISION" (P.B. 4, PP. 168 AND 169), PART OF LOTS 318 AND 319 OF "NEW INDIANOLA ADDITION" (P.B. 12, PP. 35 AND 36), AND PART OF LOTS 33 TO 43, BOTH INCLUSIVE, AND ALL OF LOTS 44 TO 53, BOTH INCLUSIVE, OF "AMENDED PLAT OF CORNELIA F. DAVIS AND OTHERS SUBDIVISION" (P.B. 17, PP. 154 AND 155) AND VACATED RIGHTS-OF-WAY)

Situated in the State of Ohio, County of Franklin, City of Columbus and in Quarter Township 4, Township 1, Range 18, United States Military Lands, containing 2.728 acres of land, more or less, said 2.728 acres being comprised of 1) all of Lots 104 to 117, both inclusive, and part of Lot 103 and part of Lots 121 to 134, both inclusive, as the same are numbered and delineated upon the subdivision plat entitled "Felix A. Jacob's Subdivision" and shown of record in Plat Book 4, Pages 168 and 169, 2) part of Lots 318 and 319 as the same are numbered and delineated upon the subdivision plat entitled "New Indianola Addition" and shown of record in Plat Book 12, Pages 35 and 36, 3) part of Lots 34 to 43, both inclusive, and all Lots 44 to 57, both inclusive, as the same are numbered and delineated upon the subdivision plat entitled "Amended Plat of Cornelia F. Davis and Others Subdivision" and shown of record in Plat Book 17, Pages 154 and 155, said Lots 103 to 117, Lots 121 to 134, Lots 318 and 319, and Lots 34 to 53, having been conveyed to WEINLAND PARK DEVELOPMENT, LLC by deed of record in Instrument Number 200810080150639, and 4) all of Lot 33 of said "Amended Plat of Cornelia F. Davis and Others Subdivision" conveyed to WEINLAND PARK DEVELOPMENT, LLC by deed of record in Instrument Number 200909290140785, Recorder's Office, Franklin County, Ohio. Portions of said 2.728 acres further being a vacation of the unnamed right-of-way by City of Columbus Ordinances: 1271-71, 1593-65, 471-48,932-63 and 900-59.

The undersigned, WEINLAND PARK DEVELOPMENT, LLC, an Ohio limited liability company, by BRIAN R. BARRETT, Member, owner of the lands platted herein, duly authorized in the premises, does hereby certify that this plat correctly represents its "WEINLAND PARK", a subdivision containing Lots numbered 1 to 35, both inclusive, does hereby accept this plat of same and dedicates to public use, as such, all of the Alleys, shown hereon and not heretofore dedicated.

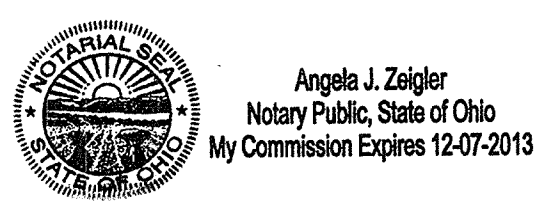

SURVEY DATA:

BASIS OF BEARINGS: The bearings shown hereon, are based on the Ohio State Plane Coordinate System, South Zone, NAD83 (CORS96). Said bearings originated from a field traverse which was tied (referenced) to said coordinate system by GPS observations of selected CORS base stations in the National Spatial Reference System. The portion of the east right-of-way of Sixth Street, having a bearing of North 03° 13' 06" East and monumented as shown hereon, is designated as the "basis of bearing" for this plat.

SOURCE OF DATA: The sources of recorded survey data referenced in the plan and text of this plat, are the records of the Recorder's Office, Franklin County, Ohio.

IRON PINS: Iron pins, where indicated hereon, unless otherwise noted, are to be set and are iron pipes thirteen sixteenths inch inside diameter, thirty inches long with a plastic plug placed in the top end bearing the initials EMHT INC.

PERMANENT MARKERS: Permanent markers, where indicated hereon, are to be one-inch diameter, thirty-inch long, solid iron pins. Pins are to be set to monument the points indicated, and set with the top end flush with the surface of the ground and then capped with an aluminum cap stamped "EMHT INC." Once installed, the top of the cap shall be marked (punched) to record the actual location of the point.
