Thence South 07° 32' 38" West, continuing with said proposed boundary line, a distance of 47.04 feet, to a point;

South 04° 36' 30" West, continuing with said proposed boundary line, a distance of 11.19 feet to a point of curvature;

Thence across said 30.92 acre tract the following courses and distances:

With a curve to the left, having a central angle of 01° 25' 36", a radius of 499.50 feet, an arc length of 12.44 feet, and a chord bearing and distance of North 01° 17' 00" West, 12.44 feet, to a point;

North 01° 59' 48" West, a distance of 190.78 feet to a point of curvature;

With said curve to the right, having a central angle of 05° 52' 31", a radius of 200.50 feet, an arc length of 20.56 feet, and a chord bearing and distance of North 00° 56' 27" East, 20.55 feet to a point;

North 03° 52' 42" East, a distance of 29.62 feet to a point of curvature;

With said curve to the left, having a central angle of 18° 32' 20", a radius of 29.50 feet, an arc length of 9.55 feet, and a chord bearing and distance of North 05° 23' 27" West, 9.50 feet, to a point in said southerly right-of-way line, the line common to the remainder of said 30.92 and 0.248 acre tracts;

Thence South 86° 24' 25" East, with said southerly right-of-way line, said common line, a distance of 11.31 feet, to the TRUE POINT OF BEGINNING, containing 0.059 acre, more or less.
