Resource One Computer Systems Inc. Advanced Technology Services, Inc. United Recycling Industries, Inc.

Resource One Computer Systems Inc. was determined by the selection team to have presented the best proposal and was awarded the initial contract that will expire on February 28, 2007 funded under purchase

order, EE003261. Therefore, the Department of Technology is requesting that the provisions of Chapter 329.11 and 329.30 of the Columbus City Code pertaining to formal bidding and to the sale of city-owned personal property to be waived.

United Recycling gave us no pricing at all, only their qualifications.

Advanced Technical Services (ATI) provided single page price list of various services. Very good qualifications, but not local and since this is a new service, a decision to stay local due to our need to be close to the project.

Resource one gave us a two (2) page price list of services.

We chose Resource One as they have the services and expertise we were looking for, is local and easily verified for the services needed. They are also a M1A as identified by the EBOCO office.
