Said monument being at the southwest corner of a 0.22 acre City of Columbus parcel **136-WD** (DB 3247, PG 178) and the northwest corner of a 1.14 acre City of Columbus parcel **135-WD** (appropriate in Franklin County Court of Common Pleas Case No. 72CV-06-1974, DB 3407, PG 347).

Thence South 25° 02' 50" West a distance of 475.61 feet, along the centerline of right of way of Georgesville Road from the year 1827, also being the west line of said parcel 135-WD to a point being the northeast corner of a 0.036 acre City of Columbus, Ohio parcel 127-WD (DB 3245, PG 683) and being 14.77 feet left of the current centerline of right of way Georgesville Road station 104+14.40;
