Grantor/Owner herein retains the right to use said real estate for any and all other purposes provided that such use does not interfere with nor impair the exercise of the easement herein granted (as used herein, the expression "Grantor/Owner" includes the plural, and words in the masculine include the feminine or neuter).

[Surveyor's description of the premises follows]

Situated in the State of Ohio, County of Franklin, City of Columbus, Section 26, ½ Section 39, Township 5, Range 22, Refugee Lands, being a strip of land located within that 1.005-acre tract as described in a deed to Mohammad Al-Mahmoud, of record in Instrument No. 200406160139152, Recorder's Office, Franklin County, Ohio, said strip being on the RIGHT side of Lockbourne Road (and north of S.R. 104) as delineated upon plans prepared for the City of Columbus and designated as 2746 DR. E, and being more particularly described as follows:

All references herein to station and offset are to the centerline of construction of Lockbourne Road.

Beginning at the intersection of the northerly line of said 1.005-acre tract and the easterly right-of-way line of Lockbourne Road located 30.00 feet RIGHT of station 72+16.55;

Thence South 86°13'35" East, along said northerly line, a distance of 5.00 feet to a point located 35.00 feet RIGHT of station 72+16.56;

Thence through said 1.005-acre tract the following courses:

1. South 03°54'25" West, a distance of 46.56 feet to a point located 35.00 feet RIGHT of station 71+70.00;
2. South 86°05'35" East, a distance of 10.00 feet to a point located 45.00 feet RIGHT of station 71+70.00;
3. South 03°54'25" West, a distance of 10.00 feet to a point located 45.00 feet RIGHT of station 71+60.00;
4. North 86°05'35" West, a distance of 10.00 feet to a point located 35.00 feet RIGHT of station 71+60.00;

5. South 03°54'25" West, a distance of 93.44 feet to a point in the southerly line of said 1.005-acre tract located 35.00 feet RIGHT of station 70+66.56;

Thence North 86°13'35" West, along said southerly line, a distance of 5.00 feet to a point in the easterly right-of-way line of Lockbourne Road located 30.00 feet RIGHT of station 70+66.55;

Thence North 03°54'25" East, along said right-of-way line, a distance of 150.00 feet to the place of beginning.

Containing 0.0195 acre of land, of which the present road occupies 0.0000 acre leaving a net take of 0.0195 acre.

Bearings herein are based on field observations of established control points from the Franklin County Engineers Office, resulting in a bearing of North 03°54'25" East, for the existing centerline of Lockbourne Road north of Marion Road.
