BACKGROUND:

- The site consists of an undeveloped parcel in the PUD-8, Planned Unit Development District. The applicant is requesting the ARLD, Apartment Residential District to permit a multi-unit residential development with a maximum of 17.4 units per acre.
- To the north of the site is a park in the R-2, Residential District and a multi-unit residential development in the PUD-8, Planned Unit Development District. To the south are single-unit dwelling in the ARLD, Apartment Residential District. To the east are single-unit dwelling in the R-2F, Residential District and a multi-unit residential development in the ARLD, Apartment Residential District. To the west is a religious facility in the L-I. Limited Institutional District.
- Concurrent CV23-075 has been filed to reduce the perimeter yard requirements. That request will be heard by City Council and will not be considered at this Development Commission meeting.
- The site is located within the boundaries of the Mideast Area Commission, whose recommendation is for approval.
- The traffic access study is under review by the Division of Traffic Management to assess what transportation improvements infrastructure may be required at the intersection of Weyburn Road and the access road.

CITY DEPARTMENTS' RECOMMENDATION: Conditional Approval *Approval

The requested ARLD, Apartment Residential District will permit a multi-unit residential development containing up to 112 apartment units. The Division of Traffic Management can be supportive of the proposal upon the condition that the developer commits to make an in-kind contribution toward transportation improvements at the intersection of Refugee Road and Weyburn Road, if determined to be necessary by the Division of Traffic Management's review and approval of the traffic access study. Upon resolution of the outstanding comments from the

Department of Public Service, the City Departments' recommendation will be revised to full approval. ***City Departments' recommendation has been updated to approval.**
