

PARCEL 39-WD

Situated in State of Ohio, County of Franklin, City of Columbus, in Section 39, Township 5, Range 22, Refugee Lands being part of a 1.000 acre tract conveyed to Bruce A. Jones by Official Record 14897 Page D09 as recorded in the Franklin County Recorder's Office and being more particularly described as follows:

Commencing from the intersection of Lockbourne Road (R/W varies) and Smith Road (R/W varies) and being centerline Station 30+00.00 Smith Road said point being North 86° 09' 47" West, a distance of 338.55 feet from an iron pin set in a monument box at the intersection of Smith Road and Smith Court;

Thence South 86° 09' 47" East, a distance of 1497.74 feet, passing said monument box at 338.55 feet, along the existing centerline of Smith Road to a point at the northwesterly corner of said 1.000 acre tract and being on centerline Station 44+97.74 Smith Road and being the TRUE **POINT OF BEGINNING**;

Thence **South 86° 09' 47" East**, a distance of **78.93 feet** along said existing centerline to a point on the westerly line of a parcel of land conveyed to Brenda J. Green by Official Record 4891 Page C20 and being at centerline Station 45+76.47 Smith Road;

Thence South 03° 36' 33" West, a distance of 25.00 feet leaving said centerline and along said westerly line of the Green parcel to an iron pin set 25.00 feet right of centerline Station 45+76.77 Smith Road;

Thence **North 86° 09' 47" West**, a distance of **78.93 feet** leaving said westerly line and across the grantor's property to an iron pin set on the easterly line of a parcel of land conveyed to The Board of Education, of Marion Township, Franklin County. Ohio by Deed Book 560 Page 327 and re-recorded in Deed Book 703, Page 525 and being 25.00 feet right of centerline Station 44+97.84 Smith Road;

Thence North 03° 36' 33" East, a distance of 25.00 feet along said westerly line of the Board of Education parcel to the TRUE POINT OF BEGINNING and containing 0.045 acres, more or less, of which 0.027 acres are within the present road occupied.

Of the above described tract, 0.045 acres, more or less, are located within Auditor's Parcel No. 010-112139.

The project is reference to the State Plane Coordinate System South Zone NAD 83 (NSRS 2007). Coordinates originated from Franklin County Engineer's monuments FRANK 134 and 33 RESET. A bearing of South 86° 09' 47" East was used for Smith Road.
