

PARCEL 27-WD

Situated in State of Ohio, County of Franklin, City of Columbus, in Section 39, Township 5, Range 22, Refugee Lands being part of a 0.201 acre tract conveyed to Jared Brooks by Instrument Number 201111080144323 as recorded in the Franklin County Recorder's Office and being more particularly described as follows:

Commencing from the intersection of Lockbourne Road (R/W varies) and Smith Road (R/W varies) and being centerline Station 30+00.00 Smith Road said point being North 86° 09' 47" West, a distance of 338.55 feet from an iron pin set in a monument box at the intersection of Smith Road and Smith Court;

Thence South 86° 09' 47" East, a distance of 968.05 feet, passing said monument box at 338.55 feet, along the existing centerline of Smith Road to a point at the southwesterly corner of said 0.201 acre tract and being on centerline Station 39+68.05 Smith Road and being the **TRUE POINT OF BEGINNING**;

Thence North 03° 52' 13" East, a distance of 25.00 feet along the easterly line of a parcel of land conveyed to Megan Hovanes by Instrument Number 201405050054972 to an iron pin set 25.00 feet left of centerline Station 39+68.07 Smith Road;

Thence **South 86° 09' 47" East**, a distance of **49.83 feet** leaving said easterly line of the Hovanes parcel and across the grantor's property to an iron pin set on the westerly right of way line of Weiler Avenue (50' R/W, PB 22, PG 122) and being 25.00 feet left of centerline Station 40+17.89 Smith Road;

Thence South 03° 52' 13" West, a distance of 25.00 feet along said westerly right of way line to a point on the existing centerline of Smith Road on centerline Station 40+17.88 Smith Road;

Thence North 86° 09' 47" West, a distance of 49.83 feet along said existing centerline to the TRUE POINT OF BEGINNING and containing 0.029 acres, more or less, of which 0.017 acres are within the present road occupied.

Of the above described tract, 0.029 acres, more or less, are located within Auditor's Parcel No. 010-113201.

The project is reference to the State Plane Coordinate System South Zone NAD 83 (NSRS 2007). Coordinates originated from Franklin County Engineer's monuments FRANK 134 and 33 RESET. A bearing of South 86° 09' 47" East was used for Smith Road.

The stationing of Smith Road is arbitrary and is based on the intersection of Smith Road and Lockbourne Road being 30+00.00.
