The following information has been provided concerning the City of Columbus' 2014 – 2015 annual objection to the renewal of liquor permits. After reviewing the State of Ohio, Franklin County, and City of Columbus' records regarding the above listed liquor permit establishment, the following information has been compiled with regard to a potential objection to the renewal of the permit issued by the State of Ohio.

The above listed liquor establishment has been issued a liquor permit from the State of Ohio, Division of Liquor Control, Permit # 8484439. The permit holder received a D5, & D6 permit. These permits grant the permit holder the privilege to sell beer and/or intoxicating liquor for on premises consumption as described by Ohio Law.

An "Inquiry of Violations" was received from the State of Ohio, Division of Liquor Control. The inquiry revealed that the permit holder has received the following administrative violations within the past 12 months

**Case Number: 08**

**01/24/2014**

The Permit Holder has been charged with the violation of Refilling and/or Dilution. This case has been assigned a case number 883-14 by the Liquor Control Commission. A hearing was held before the Liquor Control Commission on 11/05/2014, at which time the Commission sustained the above violation. The Liquor Control Commission ordered that the Permit Holder pay a \$800 fine by 12/17/2014 or serve a 4 day suspension.

**Case Number: 07**

**07/25/2014**

The Permit Holder has been charged with the violations of Receiving Stolen Property. This case has not been assigned a case number by the Liquor Control Commission.

**Case Number: 06**

**08/01/2014**

The Permit Holder has been charged with the violations of Illegal Possession of Intoxicating Liquor, Improper Conduct receiving and/or Concealing Stolen Property, Improper Conduct Theft by Deception, and Illegal Possession Intoxicating Not Obtained from Authorized Source.. This case has not been assigned a case number by the Liquor Control Commission.


