Situated in the State of Ohio, City of Columbus, Franklin County, Fractional Section 5, Township 5, Range 22, in Scofield's Survey of the Refugee Lands, and being part of Lot 1, of Catherine Whites's Subdivision of Lots 16 & 17 of Deshlers Addition to Phelan's MT Pleasant Addition to Columbus, Ohio, as recorded in Plat Book 3, page 246 and conveyed to Rebecca S. Lamb and Matteo Citarelli in Instrument 200403170058277 in the Franklin County Recorder's Office. The below described parcel laying on the right side of Hamlet Street, and being more particularly described as follows:

COMMENCING at an 8" Mag Nail set on the intersection of Right of Way lines of Hamlet Street (25' R/W) and a 15' Alley, at the southwest corner of said Lot 1, Thence, along the south line of Lot 1, the grantor's south line and the north existing Right of Way for a 15' alley, South 86 degrees 40 minutes 49 seconds East, 2.04 feet to an iron pin set, said iron pin set being the **TRUE POINT OF BEGINNING** for the parcel herein described:

- 1) **Thence**, across the grantor's tract, **North 09 degrees 01 minutes 21 seconds West, 35.41 feet** to an iron pin set;
- 2) **Thence**, across the grantor's tract, **North 81 degrees 47 minutes 11 seconds East, 2.00 feet** to a point;
- 3) **Thence**, across the grantor's tract, **South 09 degrees 01 minutes 21 seconds East, 35.82 feet** to a point on the south line of Lot 1, being the grantor's south line and the north existing Right of Way for a 15' alley;
- 4) **Thence**, along the south line of Lot 1, the grantor's south line and the north existing Right of Way for a 15' alley, **North 86 degrees 40 minutes 49 seconds West, 2.05 feet** to the **TRUE POINT OF BEGINNING**, containing 0.002 acres.
