The following information has been provided concerning the City of Columbus' 2014 – 2015 annual objection to the renewal of liquor permits. After reviewing the State of Ohio, Franklin County, and City of Columbus' records regarding the above listed liquor permit establishment, the following information has been compiled with regard to a potential objection to the renewal of the permit issued by the State of Ohio.

The above listed liquor establishment has been issued a liquor permit from the State of Ohio, Division of Liquor Control, Permit # 95559333005. The permit holder received a C1 permit, a C2 permit, & D6 permit.. These permits grant the permit holder the privilege to sell beer and/or intoxicating liquor for off premises consumption as described by Ohio Law.
