**PARCEL 42-P  
0.002 ACRE (OR 92.04 SQUARE FEET)  
PERMANENT EASEMENT  
TO CONSTRUCT A CURB RAMP AND SIDEWALK  
WITHOUT LIMITATION OF EXISTING ACCESS RIGHTS  
IN THE NAME AND FOR THE USE OF  
THE CITY OF COLUMBUS, FRANKLIN COUNTY, OHIO**

An exclusive perpetual easement for public highway and road purposes, including, but not limited to any utility construction, relocation, and/or utility maintenance work deemed appropriate by the City of Columbus, its successors and assigns forever.

Grantor/Owner, for himself and his heirs, executors, administrators, successors and assigns, reserves all existing rights of ingress and egress to and from any residual area (as used herein, the expression "Grantor/Owner" includes plural, and words used in masculine include the feminine or neuter).

[Surveyor's description of the premises follows]

Situated in the State of Ohio, County of Franklin, City of Columbus, Clinton Township, being in Quarter Township 4, Township 1 North, Range 18 West of the United States Military Lands, being part of Lot 5 of Hiawatha Park Place as recorded in Plat Book volume 14, page 32 (all document references are to the records of Franklin County unless otherwise stated), and being a 0.002 acre parcel out of that tract known as Franklin County Auditor's **Parcel Number 010-074286** as conveyed to **L.L.I.J. Company, an Ohio Partnership** (hereafter referred to as "Grantor") by the instrument filed as **Official Record volume 25834, page I16**.

Being a parcel of land lying on the right side of the existing centerline of right-of-way of Hudson Street (60' R/W – Public) and being more particularly described as follows:

**COMMENCING FOR REFERENCE** at a 1" iron pin set in a monument box on the centerline of right-of-way of Hudson Street, being at the northwest corner of Hiawatha Park Place as recorded in Plat Book 14, page 32, and being at an angle point in the said centerline of right-of-way of Hudson Street, said pin being at station 28+66.08 of the said centerline of right-of-way of Hudson Street;

Thence along the said centerline of right-of-way of Hudson Street, **South 86 degrees 22 minutes 37 seconds East for a distance of 224.78 feet** to a point being at station 30+90.86 of the centerline of right-of-way of Hudson Street;

Thence leaving the centerline of right-of-way of Hudson Street perpendicularly, **South 03 degrees 37 minutes 23 seconds West for a distance of 30.00 feet** to a point at the Grantor's northeast corner, the northeast corner of the said Lot 5, and being at the intersection of the existing southerly right-of-way line of Hudson Street and the westerly right-of-way line of

Pontiac Street, said spike being 30.00 feet right of the centerline of right-of-way of Hudson Street station 30+90.86 said spike being the **TRUE POINT OF BEGINNING** of the parcel herein described;

Thence along the Grantor's easterly line, the easterly line of the said Lot 5, and along the said westerly right-of-way line of Pontiac Street, **South 03 degrees 24 minutes 38 seconds West for a distance of 7.18 feet** to a point being 37.18 right of the centerline of right-of-way of Hudson Street station 30+90+89;

Thence crossing through the lands of the Grantor and through the said Lot 5, **North 86 degrees 22 minutes 37 seconds West for a distance of 5.64 feet** to a point being 37.18 feet left of the centerline of right-of-way of Hudson Street station 30+85.25;

Thence continuing along the last said line, **North 59 degrees 51 minutes 16 seconds West for a distance of 16.07 feet** to a point on the Grantor's northerly line, on the northerly line of the said Lot 5, and on the said existing southerly right-of-way line of Hudson Street, said point being 30.00 feet left of the centerline of right-of-way of Hudson Street station 30+70.86;

Thence along the Grantor's northerly line, the said northerly line of Lot 5, and the said existing southerly right-of-way line of Hudson Street, **South 86 degrees 22 minutes 37 seconds East for a distance of 20.00 feet** to the **TRUE POINT OF BEGINNING** of the parcel herein described.

The above description contains a total area of **0.002 acres (0.000 acres are located within the Present Road Occupied resulting in a net take of 0.002 acres)**, out of Franklin County Auditor's **Parcel number 010-074286**.

Prior instrument of record as of this writing recorded in **Official Record volume 25834, page I16** in the records of Franklin County.

This description was prepared by Andrew T. Jordan, Ohio Registered Professional Surveyor number 8759, and is based on an actual field survey conducted by American Structurepoint Inc., and is true and correct to the best of my knowledge and belief.

The bearing for this description are based on Grid North as referenced to South 86 degrees 18 minutes 11 seconds East for the centerline of right-of-way of Hudson Street east of Interstate Route 71 (FRA-1-25.33) as referenced to the Ohio State Plane coordinate system (South Zone) and the North American Datum of 1983, as established utilizing a GPS survey and NGS OPUS solution.

The stations referenced herein are from the plans known as Hudson Street on file with City of Columbus, Ohio having "E" plan number 3575.
