## PERMANENT EASEMENT

Situated in the State of Ohio, County of Franklin, City of Columbus, located in Lot No. 8 of the "J. J. Briggamon" subdivision of record in Plat Book 1, Page 292, and being 0.0009 acre out of the tract conveyed to Timothy Charles Keny and James McCellen Keny in Instrument Number 198002280004045 (further shown upon the attached exhibit), and being described as follows:

**Commencing** at the intersection of the centerline of right-of-way of Beck Street (34 feet in width) and the centerline of right-of-way of Jaeger Street (21 feet in width);

Thence North 85° 45' 06" West, along the said centerline of right-of-way of Beck Street, a distance of 15.08 feet to a point;

Thence North 04° 14' 54" East, leaving the aforesaid centerline of right-of-way, a distance of 17.00 feet to a point in the northerly right-of-way line of said Beck Street at the southeasterly corner of the 0.115 Acre tract conveyed to Kristina L. Jacobson, Tr. in Instrument Number 201005040054490, being the **Point of Beginning** for the herein described easement;

Thence North 03° 50' 44" East, leaving the said northerly right-of-way line of Beck Street and along the easterly line of the said Kristina L. Jacobson, Tr. tract, a distance of 1.80 feet to a point;

Thence South 85° 45' 06" East, leaving the said easterly line of the said Kristina L. Jacobson, Tr. tract, and through the said Timothy Charles Keny and James McCellen Keny tract, a distance of 21.56 feet to a point;

Thence South 04° 14' 54" West, continuing through the said Timothy Charles Keny and James McCellen Keny tract, a distance of 1.80 feet to a point in the said northerly right-of-way line of said Beck Street;

Thence North 85° 45' 06" West, along the aforesaid northerly right-of-way line, a distance of 21.55 feet to the **Point of Beginning**.

**Commencing** at the intersection of the centerline of right-of-way of Beck Street (34 feet in width) and the centerline of right-of-way of Jaeger Street (21 feet in width);

Thence North 85° 45' 06" West, along the said centerline of right-of-way of Beck Street, a distance of 15.08 feet to a point;

Thence North 04° 14' 54" East, leaving the aforesaid centerline of right-of-way, a distance of 17.00 feet to a point in the northerly right-of-way line of said Beck Street at the southeasterly corner of the 0.115 Acre tract conveyed to Kristina L. Jacobson, Tr. in Instrument Number 201005040054490;

Thence North 03° 50' 44" East, leaving the said northerly right-of-way line of Beck Street and along the easterly line of the said Kristina L. Jacobson, Tr. tract, a distance of 1.80 feet to a point, being the **Point of Beginning** for the herein described easement;

Thence North 03° 50' 44" East, continuing along the said easterly line of the said Kristina L. Jacobson, Tr. tract, a distance of 4.20 feet to a point;

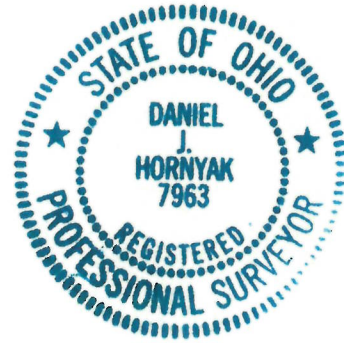

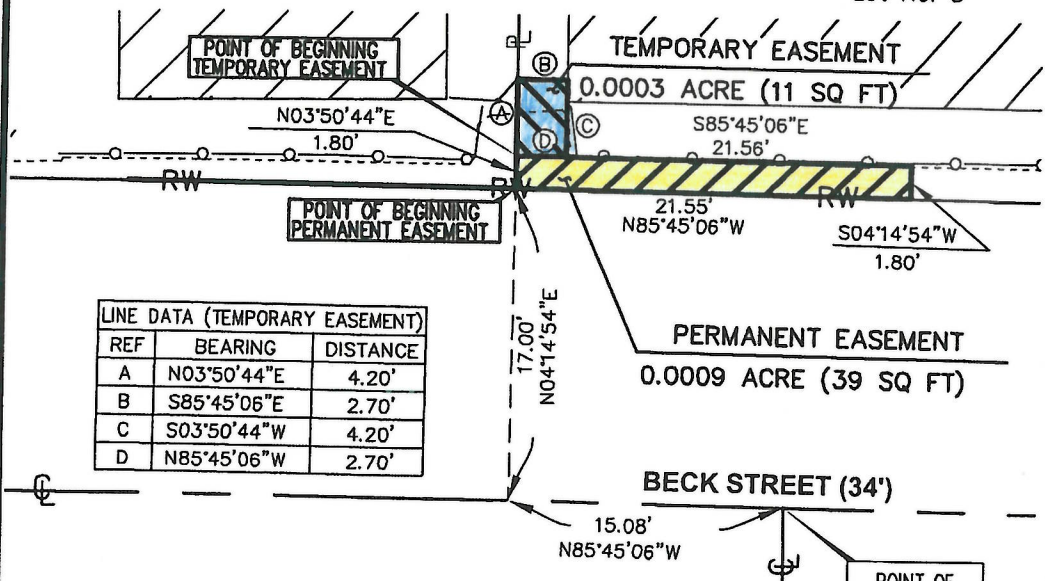
