**[Surveyor's description of the premises follows]**

Situated in the State of Ohio, County of Franklin, City of Columbus, being located in Virginia Military Survey Number 1390, and being a part of that original 35.936 acre tract (now 15.038 acres of record by the Franklin County Auditor) described in a deed to **The Board of Education of the City School District of Columbus, Ohio**, of record in Deed Book 1977, page 564, all records referenced herein are on file at the Office of the Recorder for Franklin County, Ohio, being a parcel of land located on the right side of the centerline of survey and right-of-way for Valleyview Drive, as said centerline is depicted on the centerline plat for the Hague Avenue-Valleyview Drive right-of-way plans, of record in Instrument Number 201209270144475 (Plat Book 115, pages 36-37), and being further bounded and described as follows:

Commencing for reference from the northeast corner of said original 35.936 acre tract, being the northwest corner of that 3.000 acre tract described in a deed to Luther B. Turner Lodge No. 732 Free & Accepted Masons, of record in Deed Book 1919, page 134 and Instrument Number 201011160153898, said corner being on the existing centerline of survey and right-of-way for Valleyview Drive, and said corner being at Valleyview Drive centerline of survey and right-of-way Station 33+02.47;

Thence **South 03 degrees 32 minutes 53 seconds East**, along the east line of said original 35.936 acre tract, along the west line of said 3.000 acre tract, a distance of **30.15 feet** to a point on the existing south right-of-way line for said Valleyview Drive, said point being 30.00 feet right of Valleyview Drive centerline of survey and right-of-way Station 33+05.50, and said point being the **TRUE POINT OF BEGINNING** for the herein described temporary easement;

Thence **South 03 degrees 32 minutes 53 seconds East**, continuing along the east line of said original 35.936 acre tract and along the west line of said 3.000 acre tract, a distance of **20.10 feet** to a point, said point being 50.00 feet right of Valleyview Drive centerline of survey and right-of-way Station 33+07.52;

Thence across said original 35.936 acre tract along the following ten (10) described courses:

1. **North 78 degrees 58 minutes 55 seconds West**, a distance of **78.44 feet** to a point, said point being 38.00 feet right of Valleyview Drive centerline of survey and right-of-way Station 32+30.00;
2. **North 87 degrees 46 minutes 53 seconds West**, along a line parallel to and 8.00 feet southerly from the existing south right-of-way line for said Valleyview Drive, a distance of **200.00 feet** to a point, said point being 38.00 feet right of Valleyview Drive centerline of survey and right-of-way Station 30+30.00;
3. **South 67 degrees 12 minutes 06 seconds West**, a distance of **16.55 feet** to a point, said point being 45.00 feet right of Valleyview Drive centerline of survey and right-of-way Station 30+15.00;
4. **North 87 degrees 46 minutes 53 seconds West**, along a line parallel to and 15.00 feet southerly from the existing south right-of-way line for said Valleyview Drive, a distance of **50.00 feet** to a point, said point being 45.00 feet right of Valleyview Drive centerline of survey and right-of-way Station 29+65.00;
5. **North 02 degrees 13 minutes 07 seconds East**, along a line perpendicular from the previous course, a distance of **15.00 feet** to a point on the existing south right-of-way line for said Valleyview Drive, said point being 30.00 feet right of Valleyview Drive centerline of survey and right-of-way Station 29+65.00;
6. **South 87 degrees 46 minutes 53 seconds East**, along the existing south right-of-way line for said Valleyview Drive, a distance of **307.38 feet** to a point, said point being 30.00 feet right of Valleyview Drive centerline of survey and right-of-way Station 32+72.38;
7. **South 02 degrees 13 minutes 07 seconds West**, along a line perpendicular from the previous course, a distance of **5.00 feet** to a point, said point being 35.00 feet right of Valleyview Drive centerline of survey and right-of-way Station 32+72.38;
8. **South 87 degrees 46 minutes 53 seconds East**, along a line parallel to and 5.00 feet southerly from the existing south right-of-way line for said Valleyview Drive, a distance of **10.00 feet** to a point, said point being 35.00 feet right of Valleyview Drive centerline of survey and right-of-way Station 32+82.38;

9. **North 02 degrees 13 minutes 07 seconds East**, along a line perpendicular from the previous course, a distance of **5.00 feet** to a point on the existing south right-of-way line for said Valleyview Drive, said point being 30.00 feet right of Valleyview Drive centerline of survey and right-of-way Station 32+82.38;
  
10. **South 87 degrees 46 minutes 53 seconds East**, along the existing south right-of-way line for said Valleyview Drive, a distance of **23.12 feet** to the **TRUE POINT OF BEGINNING** for the herein described temporary easement.

The above described temporary easement contains an area of **0.081 acres** (including 0.000 acres within the present road occupied) within Franklin County Auditor tax parcel number 010-111409.

The bearings described herein are based on the centerline of survey and right-of-way for Valleyview Drive (South 87 degrees 46 minutes 53 seconds East) and grid north referenced to the North American Datum of 1983 (NSRS 2007 Adjustment) and the Ohio State Plane Coordinate System (South Zone), as established utilizing a GPS survey originating on Franklin County Engineer Survey Control Monuments "ST01" and "FCGS 5335".

The above description of a temporary easement was prepare and reviewed by Brian P. Bingham, Registered Professional Surveyor No. 8438 on June 19, 2012, is based on an actual survey performed in the field by American Structurepoint, Inc., and is true and correct to the best of my knowledge and belief.
