The Department of Public Service solicited Requests for Proposals for the Roadway Improvements – Scioto Peninsula contract. The recommendation is to award EMH&T, the consultant that was scored the highest by the selection committee. Details concerning the recommendation are below. The Department of Public Service is initiating a procurement effort that will result in the award and execution of a detailed design contract. This project involves the preparation of detailed design plans, which will include new pavement, curb, sidewalks, storm sewer, water main, sanitary sewer, street and pedestrian lighting, landscaping, signals, undergrounding overhead utilities, and all appurtenances within the Scioto Peninsula. The Scioto Peninsula is the areas bounded by the Scioto River and the Norfolk Southern Railroad. The purpose of this project is to upgrade the existing infrastructure to accommodate future development.

The contract will be funded from DPS' 2014 CIB. The project was formally advertised on the Vendor Services web site from February 11, 2014, to March 4, 2014. The city received five (5) responses. All

proposals were deemed responsive and were fully evaluated when the Evaluation Committee met on March 11, 2014. The responding firms were:

sub-consultants, and the need for cross-coordination.

3. EMH&T also understood the importance of establishing and adhering to a schedule and has previous

experience overseeing critical path projects.

4. Their past performance was the most relevant to the scope of the Scioto Peninsula project and

included other projects completed on an accelerated schedule.

5. Their project manager was involved in those and other notable projects, including the Riversouth

project.
