



BACKGROUND:

- o The 1.03± acre site is developed with a former concrete mixing plant zoned in the M, Manufacturing District. The applicants are establishing their offices at this site on the portion to be zoned CPD and wish to incorporate Graphics variances on the CPD portion. The applicants will also use some of site the currently zoned M for their manufacturing, but that aspect is not part of this rezoning.
- o To the north and east are a trail and the Scioto River zoned in the M, Manufacturing District. To the south is an abandoned industrial operation in the M, Manufacturing District. To the west is a contractor's storage yard in the M, Manufacturing District.
- o The site is within the planning area of the *Franklinton Plan* (2003), which recommends manufacturing development for the site.
- The applicant's use would be allowed at this site without a rezoning. The applicant is requesting a 200 foot height district, with a limit of 150 feet. The proposal will allow two off premise banners. The maximum size of each banner is proposed to be 120 ft. x 75 ft. A third side of structure shall be solar panels. The applicant has committed to not allowing LED signs on the proposed structure at the request of Staff.

<u>CITY DEPARTMENTS' RECOMMENDATION</u>: Approval.

Staff recommends approval of the requested CPD, Commercial Planned Development District. While it has been the long standing policy of BZS Staff to not include any substantive graphics commitments in any limitation or CPD text other than two boilerplate statements stating that the applicants will comply with the Graphics Code or file a Graphics Plan with the Graphics Commission, there is a provision in the CPD chapter that allows the applicant to utilize the CPD to address Graphics issues. BZS Staff policy has been that all Graphics issues should be handled by the Graphics Commission which was created specifically to handle Graphics issues, and rezonings should focus on land use issues and physical development standards. Incorporating Graphics Commitments in Zoning Texts circumvents Graphics Commission, whose sole focus is on Graphics issues. The applicant's proposed use would be allowed at this site without a rezoning. Although Staff is concerned about the precedent of handling graphics issues in this way, Staff has no objection to the proposed land use, development standards or the proposed graphic plan and standards.
