Parcel 4-T2 Temporary Easement 0.0160 Acres

Situated in the State of Ohio, County of Franklin, City of Columbus, Quarter Township 2, Township 1, Range 18, United States Military District, Lot 11 of Plat of Rathbone as recorded in Deed Book 15, Page 256-1/2, and being a part of a parcel conveyed to OGGI Properties II, LLC., an Ohio Limited Liability Company by Inst. No. 201208310128405 of said county records and being more particularly described as follows:

Commencing at a magnail (set) at the intersection of the current centerline of Olentangy River Rd and the northerly line of Lot 11 of said Plat of Rathbone; thence southeasterly with said centerline and a curve to the left having a radius of 1910.08 feet, a central angle of 00 Degrees 45 Minutes 18 Seconds, a chord bearing South 31 Minutes 03 Minutes 17 Seconds East, a chord distance of 25.17 feet, an arc length of 25.17 feet to a point; thence continuing with said centerline South 31 Degrees 25 Minutes 57 Seconds East, a distance of 572.88 feet to a point; thence North 58 Degrees 34 Minutes 03 Seconds East, a distance of 78.00 feet to a point on the northeasterly right of way line of said Olentangy River Rd, said point being the **TRUE PLACE OF BEGINNING** for the parcel hereinafter described; thence in a clockwise direction along the following four (4) courses;

1. Thence **North 60 Degrees 55 Minutes 18 Seconds East**, a distance of **15.76 feet** to a point;
2. Thence **South 31 Degrees 25 Minutes 57 Seconds East**, a distance of **44.00 feet** to a point;
3. Thence **South 59 Degrees 13 Minutes 41 Seconds West**, a distance of **15.75 feet** to a point on the northeasterly right of way line of said Olentangy River Rd;
4. Thence with said northeasterly right of way line **North 31 Degrees 25 Minutes 57 Seconds West**, a distance of **44.47 feet** to the **TRUE PLACE OF BEGINNING**.

The above described parcel contains 0.0160 acres, more or less, and subject to all easements, restrictions and covenants of record.

The above described area is contained within Franklin County Parcel Number 010-129667.

The bearings for this description are based on the bearing between Franklin County Engineer's Monuments "WICKLIFFE" and "W188RESET" being South 83 degrees 26 minutes 03 seconds East, as measured on Grid North, of the Ohio State Plane Coordinate System, South Zone, NAD83(2011).
