thence across said 4.4321 acre tract, the following courses and distances:

South 27° 58' 07" West, a distance of 80.18 feet to a point of curvature; and

With the arc of a curve to the left, having a central angle of 11° 36' 47", a radius of 1290.00 feet, an arc length of 261.46 feet, and a chord which bears South 22° 09' 44" West, a distance of 261.01 feet to a point in said easterly right-of-way line;

thence North 07° 24' 42" East, with said easterly right-of-way line, a distance of 103.12 feet to a point;

thence across said 4.4321 acre tract, the following courses and distances:

with the arc of a curve to the right, having a central angle of 07° 09' 10", a radius of 1310.00 feet, an arc length of 163.54 feet, and a chord which bears North 24° 23' 32" East, a distance of 163.44 feet to a point;

North 27° 58' 07" East, a distance of 72.15 feet to the TRUE POINT OF BEGINNING, containing 0.131 acre, more or less.
