ADDITIONAL PROVISIONS TO ARTICLES OF INCORPORATION OF

COLUMBUS NEXT GENERATION REAL ESTATE DEVELOPMENT CORPORATION

THIRD: PURPOSES

This Corporation is organized exclusively for charitable, religious, educational, scientific or other purposes as set forth in Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding provision of any future statute of like tenor or effect, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding provision of any future statute of like tenor or effect, as well as the qualification of the Corporation for such status and purposes.

SIXTH: MEMBERS

The Corporation is organized on a non-stock basis only. There shall be no shareholders, but the member shall be the City of Columbus for the purpose of conducting the business of the Corporation pursuant to Ohio law, as shall any other persons as determined by the Corporation's Code of Regulations.

SEVENTH: RESTRICTIONS

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in, including the publishing or distribution of statements, any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles of Incorporation, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding provision of any future federal tax code, or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

EIGHTH: DISSOLUTION

Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding section of any future federal tax code, or shall be distributed to the federal
