


## **BACKGROUND:**


- o This application was tabled by the Development Commission on December 9, 2005, to allow the applicant time to address the concerns of an adjacent property owner. The 2.01± acre site is developed with a single-family dwelling and storage building and is zoned in the L-M-2, Limited Manufacturing District. The applicant requests the L-M-2, Limited Manufacturing District to allow additional industrial and office uses on the property. The current L-M-2 District allows contractor's storage within one building only. In conjunction with this rezoning request, a companion Council variance application has been filed to permit the non-conforming single-family dwelling, as well as other variances necessary to legitimize the existing site conditions.
- o To the north, east and west are single-family dwellings zoned in the R-1, Residential District. Industrial development in the M-2, Manufacturing District abuts the remaining residential zoning districts to the north and east. To the south across Scioto Darby Creek Road is an electrical substation in the M-1, Manufacturing District.
- o The limitation text incorporates use restrictions, screening, and lighting controls that are consistent with surrounding industrial zoning districts. Although the limitation text has not been changed since the previous Development Commission meeting, the applicant has committed to a landscaped 25-foot no build zone along the north property line as referenced in a letter from the applicant dated January 5, 2006, which is included in this report.
- o The Columbus Thoroughfare Plan identifies Scioto Darby Creek Road as a 4-2 arterial requiring a minimum of 50 feet of right-of-way from centerline.

## **CITY DEPARTMENTS' RECOMMENDATION:** Approval.

The requested L-M-2, Limited Manufacturing District will allow industrial and office development. Although the site abuts residential zoning on three sides, the established development pattern for the area has been for industrial development. The limitation text incorporates use restrictions, screening, and lighting controls which allow the proposed L-M-2, Limited Manufacturing District to be more compatible with the surrounding development.
