5. **A full description of all work to be performed including a full description of work to be performed during any known phasing of the contract.**

The purpose of this project is to construct necessary improvements to the water distribution system in the Arcadia Avenue area. The improvements identified in the scope of work will replace or rehabilitate water lines that have high break histories and require frequent maintenance. This project includes replacing or rehabilitating approximately 13,400 linear feet of 6-inch and 8-inch water lines within the project area. The project also includes service transfers along 7,900 linear feet within the project area. The project area consists of the following streets: East Arcadia Avenue, Calumet Street, East Duncan Street, East Blake Avenue, East Maynard Avenue, East Patterson Avenue, East Avenue, East Northwood Avenue, Adams Avenue, Medary Avenue, and Northridge Road.

6. **A narrative timeline for the contract including a beginning date, beginning and ending dates for known phases of the contract and a projected ending date.**

The duration of the design phase for this project is 12 months. Part of the Engineer's contract is to provide Record Drawings after the construction of this project. Therefore, the contract completion date cannot be determined at this time

7. **A narrative discussing the economic impact or economic advantages of the project; community outreach or input in the development of the project; and any environmental factors or advantages of the project.**

The goal of this project is to replace or rehabilitate the existing 6-inch and 8-inch water lines that have a high break frequency. Replacement of these water lines will decrease burden on

water maintenance operations. The new lines constructed under this project should eliminate the pattern of frequent water line breaks and reduce water loss.
